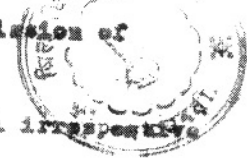

RESOLUTION: Sanction is accorded to the grant of  
lease under Rule 3 of the Part II-A of the Rules framed under  
Section 164(3) of the Madhya Pradesh Land Revenue Code, 1954,  
to the Shivaji Education Society, Amravati, of land measuring  
1225023 square feet (excluding the area reserved for Officers'  
Quarters) out of plot No. 3/1 of Sheet No. 27 of Amravati,  
district Amravati valued as a revenue free holding at  
Rs. 1,69,263/- and structures worth Rs. 60,000/- situated on  
the land, free of premium but on payment of a nominal rent  
of Rs. 53/- per annum, for the purpose of Two Years' Diploma  
Course in Agriculture and Rural Studies of Janata College,  
subject to the conditions laid down in rule referred to above  
and to the following further conditions:-

- (i) that the College building should be constructed  
within two years from the date of handing over the possession  
of the land to the Shivaji Education Society, Amravati;
- (ii) that the plans of the building should be got  
approved by the Collector and no additions or alterations  
should be made to the building without prior permission of  
the Collector;
- (iii) that the College should be open to all irrespective  
of caste or creed;
- (iv) that the land and the building thereon should be  
used for the purpose for which the grant is made and for no  
other purpose.

(v) that the grant should be conditional upon the continued recognition of the College by the Education Department;

(vi) that the building to be constructed shall comply with the prevention of ribbon development rules in force;

(vii) that the Society shall pay the cost of acquisition of land required for the Government Polytechnic on a site to be approved by Government;

(viii) that the Society shall agree to keep open 2 acres or such area, as may be necessary and decided by Government, of land in front of the Gadge Maharaj Samadhi so as to be of use to the Trust for the purposes of Yatra and shall agree to observe all the conditions, etc. that Government may decide in this behalf;

(ix) that the Society shall agree to surrender to Government without asking for any compensation the land of Plot No.2 of Sheet No.39-A or any other land possessed by the Society, as may be decided by Government later on, for the purpose of Government Polytechnic or for the purpose of the Yatra;

(x) that the Society shall not build on Plot No.3/1, Sheet No.27 until it has deposited with the Government an amount equal to the probable value of the land to be acquired at Society's cost for Government institution under condition No.(vii) above and agrees to pay the balance of the amount that may, if necessary, be required finally for acquisition of that land;

(xi) that the grant shall be liable to be revoked and the land resumed without payment of any compensation for breach of any of the conditions.



2. Sanction is also accorded to the grant on lease under Rule 3 of Part II-A of the rules framed under Section 164(3) of the Madhya Pradesh Land Revenue Code, 1954, to the Shivaji Education Society, Amravati, of land measuring 1011997 square feet of Plots No.s 1/1, and 2/1 of Sheet No. 37, Plot No.3 of Sheet No.37/A and Plot No.2/1 of Sheet No.42 of Amravati, District Amravati as shown in the margin,

per annum, for the purpose of stadium subject to the conditions laid down in rule referred to above and to the following further conditions:-

- (i) that the stadium buildings should be constructed within two years from the date of handing over the possession of the land to the Shivaji Education Society; Amravati;
- (ii) that the plans of the buildings should be got approved by the Collector and no additions or alterations should be made to the buildings without prior permission of the Collector;
- (iii) that the stadium should be open to all irrespective of caste or creed;
- (iv) that the land and the buildings thereon should be used for the purpose for which the grant is made and for no other purposes;
- (v) that the stadium should be made available free of charge to Government and public institutions such as schools, colleges, etc. if on any day it is not required by the Society's institutions, subject to such terms and for such period of the Collector directs. The Collector will be the sole judge as to whether the stadium is genuinely required by the Society's institutions on the particular days.

- (vi) that the building to be constructed shall comply with the prevention of Ribbon Development rules in force;
- (vii) that in case of land for any exhibitions or matches, etc. for which rent or fees for admission or premium is charged, 50% of the net receipts, exclusive of entertainment duty, should be credited to Government;
- (viii) that in emergency of which the Collector shall be the Sole Judge, he may even take over the stadium for any public purpose without payment of any compensation, notwithstanding its allotment by the Society for any of its own purposes or for the purpose of another institution;
- (ix) that the grant shall be liable to be revoked and the land resumed without payment of any compensation for breach of any of the conditions.

Sanction is also accorded to the grant on lease under rule 3 of the Part II-A of the Rules framed under Section 164(3) of the Madhya Pradesh Land Revenue Code, 1954 to the Shivaji Education Society, Amravati of land measuring 1441579 sq.ft. of Plot No.1 of Sheet No.20, Plot Nos. 2,4, and 6 of Sheet No.26 and Plots Nos. 3/1 and 5 of Sheet No.32 of Amravati, District Amravati as shown in the margin, valued

Training Centre, subject to the conditions laid down in rule referred to above, and to the following further conditions:-

- (1) that the Training Centre building should be constructed within two years from the date of handing over the possession of the land to the Shivaji Education Society, Amravati;



- (ii) that the plans of the building should be get approved by the Collector and no additions or alterations should be made to the building without prior permission of the Collector;
- (iii) that the Training Centre should be open to all irrespective of caste or creed;
- (iv) that the land and the building thereon should be used for the purpose for which the grant is made and for no other purposes;
- (v) that the grant should be conditional upon the continued recognition of the Training Centre by the Education Department;
- (vi) that the building to be constructed shall comply with the prevention of ribbon development rules in force;
- (vii) that the land should not be used for any profitable purposes;
- (viii) that, if the Society wishes to alter the user, from the construction of some institution which is permitted under the existing grant, to another institution, the change in user will require permission;
- (ix) that the grant shall be liable to be revoked and the land resumed without payment of any compensation for breach of any of the conditions.

4 The grant sanctioned in paragraphs 1, 2, and 3 above should be subject to the following additional conditions:-

- (i) that the land with all fixtures and structures thereon shall be liable to be resumed by Government without payment of any compensation if not used for the specific purpose or purposes for which it is granted within a period of ten years and at any time thereafter, if such user is stopped;
- (ii) that the land with all fixtures and structures thereon shall be liable to be resumed by Government if

Required by Government for any public purpose and that a declaration under the signature of the Collector that the land is so required shall, as between the grantee and the Government be conclusive. If the land is at any time resumed by Government under this condition the compensation payable therefor shall not exceed the cost or value at the time of resumption, whichever is less, of any building or other work authorizedly erected or executed by the grantee.

ORDER.

In exercise of the powers under section 20 and 31 of the M.L.A.
