Policy Decision on Reimbursement of Tuition Fees to students taking admission in recognized Private

Unaided and Permanent Unaided Institutions under the auspices of Department of Higher and Technical Education,

Department of Medical Education and Pharmaceuticals, Department of Agriculture, Animal Science, Dairy and

Fisheries Department of Government, Since 2006-07 is taken 2007-08, 2008-

09, has been maintained in 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2015-16. The proposal of the Higher and Technical Education Department regarding the commencement of the said scheme from the academic year 2015-16. It has been approved in the meeting of the committee and in accordance with the Government Scheme of Scholarship No. 1 of the Department of Higher and Technical Education in Tsyasandhab, Scholarship No. 2 has been approved in accordance with the reimbursement of education fees to the Scheduled Tribe students, Government/University/Tuition fee waiver for eligible students of Scheduled Tribes

 studying in recognized educational institutes of higher education in order to facilitate higher education for Scheduled Tribe students. Government decision number: Vy.Apr-2021/C.No.94/ Ka-12

/ Agricultural University / Other concerned fee authorities to implement the scheme of reimbursement of education fees of Scheduled Tribe students as per the rate decided by Govt.

The procedure is mentioned. It has also been amended as per the Government Corrigendum No. 4 dated 18.06.2021 in accordance with the curriculum, 3. From the academic year

2018-19, various educational schemes to be implemented in the Adivasi Development Department have been requested and implemented in a transparent manner. In order to provide benefits to the eligible students, the rules have been implemented vide Government Decision No. 3 dated 19.08.2017 regarding the deposit of net amount in the bank account of the students in

Aadhaar attachment, 4. It has been decided to implement the said scheme from the academic year 2018-19 through MahawadBT sub-division and approval of education fee reimbursement to Scheduled Tribe students is also done from the said sub-division. Distribution of Education Fee Reimbursement Scheme for Vocational Courses to Scheduled Tribe Students vide Government Decision No. 2, 4, 5 and 6 vide Government Decision No. 31.03.2016 and Government Corrigendum No. 05.03.2020, No. 18.06.2021 and No. 20.07.2021 This procedure has been mentioned The said government decision is being processed. Regarding the scheme of reimbursement of education fees to Scheduled Tribe students taking admission in vocational courses, the matter of the government was under the consideration of the government to prepare a new procedure for distributing education fee reimbursement by consolidating the government's circulars.

Governance decision -

The scheme for the reimbursement of education fees of Scheduled Tribe students enrolled in vocational courses in private unaided and permanent unaided educational institutes recognized by the government of the state has been mentioned in the government decision of Grant No. 2 and the government circular of Grant No. 4, 5 and 6 and the said government decision and Govt Corrective Actions is being done.

In line with the distribution of benefits of the Scheme for Reimbursement of Education Fees to Scheduled Tribe students taking admission for vocational courses in private unaided and permanent unaided educational institutions in the state, the following revised arrangements are being made. As per the said rule, the procedure for distributing the benefits of the education fee reimbursement scheme to the Scheduled Tribe students is as follows.

### 1) Gist of the

Scheme - In order to facilitate higher education for Scheduled Tribe students, eligible Scheduled Tribe students pursuing higher education in recognized educational institutions will be provided with State Govt. recognized private unaided tuition fees as per the rate decided by the Government/University/Tuition Fee Authority/Agricultural University/other related fee authorities. And a scheme is implemented to reimburse the education fees of Scheduled Tribe students taking admission for vocational courses in permanent unaided educational institutions.

From the academic year 2018-19, it has been decided to pay the benefits of the Scheme of Reimbursement of Education Fees of Scheduled Tribe students who take admission for vocational courses in private unaided and permanent unaided educational institutes recognized by the government from the MahawadBT fund.

Reimbursement of Education Fees to Scheduled Tribe Students from MahawadBT Potanli The process of granting benefits is also done.

The Scheme of Reimbursement of Vocational Education Fees of Scheduled Tribe Students will continue to be applicable to the Vocational Courses mentioned below.

- a) Health Science Courses (Medical, Dental, Homeopathy, Unani, Ayurveda, Physiotherapy, Business and Navsingh) – through the recruitment process conducted by the Association or Managements or Unaided Private Medical and Dental Colleges or Maharashtra, Mumbal for the purpose of Health Science Courses and the joint recruitment of the Govt. It will remain applicable for the period till the completion of the test course for the students admitted through examination (CET/NEET)/ through Advanced Placement Program (CAP). However, after completion of the said admission process, the students who have taken admission against the red seats (Against CAP) even if such admissions have been approved by the Forest Control Committee, will not get the benefit of this scheme.
- b) Courses offered in Mathematics in the Department of Higher Technical Education

It will continue to be applicable to vocational courses offered without grant in technical and other government

universities. This scheme will cover the following courses -

 c) Courses offered in the Departments of Agriculture, Animal Science and Dairy Development and Fisheries - Recognized Private Unaided and Permanent Unaided Schools/

Reimbursement of tuition fee as per the rate fixed by Maharashtra Council of Agricultural Education and Research to the students admitted from Government quota in colleges.

This repayment scheme will continue to be applicable for the following courses.

- 1) Agricultural School (Degree)
- 2) Dairy Business Development (Degree)
- 3) Colleges of Agriculture and Related Subjects (Graduate and Post Graduate)
- 4) College of Agricultural Biotechnology (Graduate and Post Graduate)
- 5) Colleges of Agriculture and Food Technology (Undergraduate and Postgraduate) d) Completed full time course of Maharashtra State Board of Technical Education after passing Class 10th School Examination (S.S.C. / C.B.S.C. and similar). E)

Also, in the future, the said scheme will be applicable to the vocational courses approved by the University Grants Commission and other universities.

# 2) Eligibility terms and conditions of State Eligibility and Colleges -

Following are the eligibility terms and conditions of Scheduled Tribe students taking admission in vocational courses in private unaided and permanent unaided educational institutes recognized by the government of the state.

- Special students should be Scheduled Tribes.
- The beneficiary of the said scheme should be a resident of Maharashtra state. Regarding that Candidates are required to have their own proof of residence.
- Children of single parents are eligible for reimbursement of education fees under this scheme.will be given.
- A student availing tuition fee reimbursement under this scheme should not have availed any other government subsidy/fee reimbursement.
- Students whose parents have an annual income of Rs. 2.50 lakhs will be eligible for this scheme.Similarly, the annual income of the parents of the candidates
  - Rs. 2.50 lakh will be less than the candidate of Government of India Post Maric Scholarship will remain eligible for benefits. Also through the Central Govt
  - The income limit for the scholarship will increase, depending on the parents of the applicants If the annual income is more than the said incremental income limit then the candidate is eligible for this scheme will qualify.
- The student is a recognized university/board equivalent of secondary, higher secondary Easy to pass the exam.
- Eligibility certificate is mandatory for admission to vocational courses.

- For courses in recognized universities and private scholarship-aided courses
   Students undergoing training will not get the benefit of this scheme.
- A student who is in employment and has enrolled in a course while in employment or has been granted leave without pay during the said course shall be eligible for the scheme or otherwise ineligible.
- 10. Colleges offering Government and University recognized, aided, unaided and private vocational courses as well as (Public Private Partnership) PPP Colleges/Institutions coming under the scheme will be eligible to avail the benefits under the scheme.
- Government and related to the college and course attended by the student.
   University/Board/Authority approval is required.
- To fill the application form of the student admitted under this scheme in the prescribed form.
   The entire responsibility will remain with the Principals of the concerned University.
- 13. Action for approval of peer review received by Mahayavadyalaya
  The Principal of the University shall make the application as per the rules and maintain a copy of the same.

- A candidate will be eligible to complete only one course.
- 15.Reimbursement of tuition fees is hereby added along with the booklet provided to Scheduled Tribe students for taking admission in government and recognized universities affiliated to government/recognised higher secondary schools/college/college.
- New and Renewal of Aji Enrollment in the College as defined by the College Updates in records.
- 17. It is mandatory for the concerned college to submit the utilization certificate of tuition fee reimbursement fee to the Darshi related project officer, Integrated Rural Development Project.
- 18. In respect of payment of tuition fees to the concerned College/ The right of inspection and inquiry of the college shall be subject to consultation under the chairmanship of the Project Officer, Integrated Rural Development Project. 19. If
- the refund of the tuition fees of the professional course is still pending as per the instructions of MahawadBT Potnal, the concerned college will remain responsible and no recovery will be possible from the student. 20. Government or subsidized educational institutions or Govt.

The above procedure will be applicable from the academic year 2021-22. 3) Annual Calendar of Distribution of Vocational and Similar Course Fee Reimbursement Scheme - The said scheme is being implemented online from the academic year 2018-19 through Mahadivati Potanli and P.R.M.S. Funds awarded to students and colleges are automatically deposited to their respective bank accounts through Wadbit system. The annual schedule of fee reimbursement for professional and similar courses of Scheduled Tribe students under this scheme is enclosed as follows.

- Initiation of new registration in Mahawadht Potnal for students who require renewal of old and new registrations in the month of June after the commencement of the academic session. Also stay tuned to MahawadBT portal for online registration till the end of December. After this, online registration for students is closed.
- After the commencement of the academic session, the Mahavadbti portal is launched for the project offices. During this period, the project offices continue to maintain a constant stream of funds received from the colleges. By doing this, the forests will be lost for a white.
- 4. In case of difficulty in the above schedule due to any exceptional reason
  From the Government level regarding changes in the schedule as per the emergency situation
  Orders will be issued accordingly.
- 4) Fees and benefits payable under the scheme -

Under Vocational and Similar Course Fee Reimbursement Scheme, fee sanction is given to eligible students as per the syllabus of the course.

- Vanish Allowance No Vanish Allowance is payable to students eligible for this scheme. 2.
- Tuition Fees and Other Allowances Scheduled Tribe students are entitled to the benefit of tuition fees as approved by the Government/University/Tuition Fee Authority/Agricultural University/other relevant fee authorities from time to time. But refundable fees should not be sanctioned to the students.
- From the year 2018-19 to Scheduled Tribe candidates through MahaydBT system.

## General Terms and Conditions of Vocational and Similar Course Fee Reimbursement Scheme -

Following are the general terms and conditions of the scheme for Scheduled Tribe students who are availing of educational fee reimbursement under Vocational and Similar Course Fee Reimbursement Schemes.

- The caste certificate of the student should be from the competent authority. Caste eligibility for students pursuing vocational and technical courses under this scheme.
   It is mandatory to submit the certificate along with AJA. Other students with this scheme
   Benefit will not be changed. (Certificate of Original Caste Validity Certificate must be completed and uploaded to MahawadBT Potanli. Not attested copy.)
- 2. In case of interruption in the course of the student, it is necessary to upload the GAP certificate and affidavit from the competent authority. In case of such students, it will be necessary for the concerned colleges to verify whether the information mentioned by the student in the gap certificate is true or false and submit such certificate along with the concerned student. A maximum gap of 5 years will be considered in the two courses of study of the students. If the gap is more than this then the concerned student will not be eligible. 3. Minimum 75 percent attendance of the student is required while sanctioning the benefit of this scheme. The responsibility of certifying in this regard will remain with the principals of the colleges.
- 4. This scheme will continue till a student completes one vocational course. (Eg Diploma Investment, Undergraduate Post etc. If a student completes Non-Professional MA Course after Professional B.Ed., then such student will not be eligible for further Professional Course. However, other

For non-vocational courses eg. M. Worl, P.A.D. Benefits for the course will turn The scheme will be applicable for any two vocational courses.

5. The student should complete the course for which he has availed this scheme. If the candidate leaves that course and enrolls for another course, the benefit for the second course will not be admissible. But such students will be allowed for another course if they return the fees of the course they have dropped to the government. (Eg - A student availed by enrolling in First Semester Vadploma Environment Learning and then enrolling in Semester Vadploma Ramancy without taking admission for Second Semester Vadploma Environment Learning, the benefit will not be admissible for the Vadploma Ramancy course. If the benefit taken for the course is returned to the government through a loan, it will be awarded under Wadploma Ramanasi.

- course.) 6. Scheduled Tribe students from states outside Maharashtra studying in this state

  However, the benefits of this scheme will not be sanctioned by the Maharashtra government.
- 7. Students who have completed one stage course and retake it for a lower stage course similar to the course but with different subjects will not get the benefit of this scheme. The benefit of this scheme can be sanctioned for the training taken according to the stages prescribed by the government regarding the training (such as graduation-post-post-graduate). (E.g. Bachelor's degree followed by LLB, Agriculture degree followed by Bachelor's degree etc. will not be eligible for this scheme.)
- 8. Students who have passed or failed in the final examination of the post or postgraduate course in Arts/Technical/Technical Certificate Examination/Diploma/Degree Course will remain eligible. However, after this, the concerned student cannot make any change in the course, if done, this scheme for the following courses.

The benefit will remain ineligible for withdrawal.

9. Under this scheme the Common Entrance Test (CET & Associate CET) of Scheduled Tribe students for Vocational Courses, Health Science Courses, Diploma in Technical Education, Degree and Post Graduate Courses, Post Graduate Diploma and Pharmacy Courses and similar professional courses, The said scheme will be applicable to those students who have been through CAP ROUND process of Govt. How to apply for open seats (CET & Associate CET) based on merit without benefit of reservation

The said scheme will also apply to the candidates admitted through the admission process (CAP ROUND). will remain Also, the professional courses for which CET is required by Govt Candidates who have no admission process and are admitted through 12th marks The said scheme will also remain open. However, admission to professional courses which Institutional level Quota and Management level Quota and Spot Round

The scheme will not be applicable to those students who have done it through Mock up Round.

- 10. The benefit provided under this scheme will remain valid for the students who have the certificate for the duration of the vocational courses developed by the government.
- 11. The said scheme will be applicable to the students who have taken the admission to the vocational course through CAP ROUND process. However, after the completion of the said admission process, the students who have taken admission in the vacant seats, even if such admissions have been approved by the admission control committee, will not benefit from this scheme.
- 12. In case of failure of an eligible student in this scheme in one academic year, he/she will remain ineligible in the next academic year. But after the passing of that session or partial pass (ATKT) in the next academic year of that course, the said will be re-eligible for the benefits of the scheme. However, if such student fails more than two times during the course of the course and is not admitted for the next academic year of the course, the enrollment in the said scheme will be permanently disqualified for the remaining period of the concerned course.
- 13. If the students/colleges submit fake and misleading information to avail the benefit under the scheme, then the benefit will not be given for the above course. And the said amount will be recovered from the concerned school/college with interest. Also, if the student is found to be misbehaving such as irregular attendance due to lack of academic progress due to lack of study, such student will not be given the benefit of this scheme.
- 14. The Government reserves the right to make changes or amendments regarding the implementation of the said scheme without giving any notice and no claim can be made against the Government by any student, college and parents for any loss due to such changes.
- 15. The condition for providing the benefit of reimbursement of tuition fees under the present scheme has not been made till the compulsory education session 2020-21. Now the institutes which are eligible to get assessment and accreditation for the academic year 2021-22 and thereafter will be required to apply to the concerned institutes for getting the assessment till the end of the next academic year. Also, it will be necessary for the educational institutions to get the assessment and grade as per the form published by the Department of Higher and Technical Education from time to time. 16. It is necessary to make available to the student in question whether the course in the concerned institution is eligible.

In the case of professional courses, the benefit of the scheme shall be admissible to the students admitted to the seats in the open groups on the basis of merit without availing the benefit of reservation. If Scheduled Tribe students are transferred to red seats in other districts, the said students will be ineligible to avail the benefits under this scheme.
- 6) Procedure for disbursement of fee refund -
  - Eligible beneficiaries enrolling in junior professional courses in educational institutions under the said scheme are still notified through computerized online system.

- 5) Aadhaar Number of Eligible Students after affiliation with the educational institution/university related to the specific computer numbers and other available personal information after the concerned student is currently enrolled in the educational institution and has appeared in the examination of the first semester of the academic year mentioned above. Also, it will be mandatory for the current project authorities to regularly submit the inspection and findings regarding the errors in the scheme to the government at the commissionerate building.

### Introduction:

Tuition fees for students taking admission in private unaided and permanent unaided institutions

A strategic policy on reimbursement has been taken up since the academic year 2006-07. The said Forest has been maintained in the academic years 2007-08, 2008-09, 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15. The proposal of the Department of Higher and Technical Education regarding the continuation of the above scheme from the academic year 2015-16 has been approved in the meeting of the Hon'ble Cabinet and in accordance with the decision of the Department of Higher and Technical Education dated 31st March, 2016, Scheduled Castes, Freed Castes, Nomadic Tribes, Other Backward Groups etc. The rate of reimbursement of tuition fees to students belonging to Specially Backward Classes was under the discretion of the Government. According to Tsaya, the government has taken the forest as follows.

### Governance decision:

16 onwards the Government approval is being given as follows:-

- 1. Expensive Education Fee Reimbursement Scheme to be implemented from the academic year 2015-16 enwards.
- The said scheme is approved as a policy without seeking the approval of the Board of Directors for the implementation of the said scheme.

- A detailed review should be undertaken by the department before the end of the next academic year regarding the improved method of implementation of the scheme;

- The authority to amend the implementation of the scheme without changing the original design has been given to the administrative departments on the advice of the Finance Department.

- A) Health Science Courses (Medical, Dental, Homeopathy, Unani, Ayurveda, Physiotherapy, Business and Navsingh):- Through the promotion process conducted by the Association of Managements of Unaided Private Medical and Dental Colleges of Maharashtra, Mumbai for the purpose of Health Science Course, the Govt. It will remain applicable for the period till the completion of the course of study for the students admitted through Common Entrance Examination. However, after the completion of the said admission process, the students who have taken admission in the remaining seats, even if such admissions have been approved by the admissions committee, will not benefit from this scheme.
- b) Under the Department of Higher Technical Education- in the State without subsidy colleges
   Applicable to vocational courses offered immediately in non-subsidized Government and subsidized colleges
   and Government Universities including /Tantrical.

c) Department of Agriculture, Animal Husbandry and Dairy Development and Fisheries: - Reimbursement of tuition fees as per the rate fixed by the Maharashtra Agricultural Education and Research Council to the students admitted from the government quota in recognized private unaided and permanent unaided schools/ colleges functioning under all the agricultural universities of the state. - d) B.Ed and D.Ed of Maharashtra Govt. Previous orders will continue to be applicable for reimbursing the course. Reimbursement of the said courses will be admissible as per the rates developed by the Department of Higher and Technical Education and School Education Department respectively of the State Government.
- 2) The said schema will continue to be applicable from the year 2015-16 onwards subject to the following terms and conditions >-
- (1) 100 percent reimbursement of tuition fee and examination fee to the students of Scheduled Castes, Freed Castes and Normadic Tribes, and Special Backward Students admitted from the academic year 2015-16 for professional courses in recognized private unaided and permanent unaided educational institutions of the state and others. 50 percent refund of tuition fee and examination fee to backward students will be admissible till completion of the course. (2) The annual income of the parents of students belonging to Scheduled Castes and Normadic Tribes, Other Backward Classes and Special Backward Classes should be within the limit of Rs.4,50 lakhs. After availing the benefits of this scheme, this Silat Tsyanam course will remain admissible till completion. Such students will not be required to submit their graduation certificate from the second year onwards. (3) The said scheme shall also be applicable for the students of Scheduled Castes, Freed Castes and Normadic Tribes, Other Backward Classes and Special Backward Classes who have taken admission in the open group seats on merit basis without availing the benefit of reservation.
- (4) The above scheme will be applicable only to the students who have received admission from Government quota.
- (5) The benefit of this scheme will be applicable to the students who have taken admission through Advanced Admission Process (CAP) of Govt. However, after the completion of the said transfer process, the students who have taken transfer to the university in the vacant seats, even if such transfer has been approved by the transfer control committee, will not benefit from this scheme.
- (6) Students taking admissions for undergraduate and postgraduate courses in Pharmaceutical Sciences and Postgraduate courses, if they have taken admissions through Key Advanced Admission Process (CAP) of Govt. However, after the completion of the said transfer process, the students who have taken transfer to the university in the vacant seats, even if such transfer has been approved by the transfer control committee, will not benefit from this scheme.
- (7) The benefit of the said scheme will be applicable to Scheduled Castes, Scheduled Castes and Nomadic Tribes, Other Backward Classes and Special Backward Classes students of Maharashtra State taking admission from AIEEE quota.
- (8) The said scheme shall not be applicable to the students taking admission for the courses in the private recognized universities and private aided universities.
- (9) The benefit provided under the said scheme is limited to the students having certificate of duration in the State of Maharashtra for advanced vocational courses developed by the Government.

- (10) The student concerned shall be eligible for benefits under any one of the various welfare schemes of the Government. That is, if the student is availing any benefit / fee waiver through other scheme then the student will not be eligible to get the benefit under this scheme.
- (11) Beneficiary students enrolled in courses under Health Sciences, Higher and Technical Education Departments and courses under Agriculture, Animal Husbandry and Dairy Development and Fisheries Departments are required to attend regularly for training in the College/Technical Institute. It is necessary to take the exam Rawal. If it is not possible to conduct the examination on special occasions, especially due to illness, it is necessary to certify the same by the concerned competent authority after making the recommendation of the concerned educational and educational Institution. (12) Eligible beneficiary students who fail to pass

a semester (service master) examination after taking admission for a vocational course, or fall in an academic year and do not get admission for that year, will be ineligible to receive the said student benefit under the scheme for the next year.

However, after passing the examination again in the same semester/year with a partial pass (ATKT) he/she will be re-eligible for the benefit of the scheme if he/she re-applies for the next academic year of the same course.

- (13) Provided that if such eligible beneficiary does not obtain admission for the next academic year of the course for more than two consecutive years in the total duration of the course after admission to the course, the benefit under the scheme shall be permanently suspended for the duration of the course in which the concerned student was enrolled. It will be different.
- (14) Beneficiary students and concerned training institutes will not be given the benefit for the duration of the above course if they submit fake or misleading information about the benefit under the scheme. Also, the entire amount of benefit received along with interest will be refunded to such student/network based on the content of the voucher submitted by them and the concerned student will be barred from receiving concession/fee refund under any of the schemes. The sole responsibility in this regard will be that of the competent authority implementing the scheme.
- (15) If it is brought to the attention of the Head of the concerned educational institution that the concerned student is not making satisfactory academic progress due to lack of satisfactory academic progress, irregular absence etc. Will it be cancelled?

- (16) If the course for which reimbursement has been provided to an eligible beneficiary student is dropped by the concerned student, the amount of reimbursement provided to such student shall be recovered from him/ her as the State Government deems fit.
- (17) The Government reserves the right to make changes or amendments in the implementation of the scheme without any notice and no claim of any student or educational institution or student's parents against the Government for any loss caused due to such changes.

After that, from the academic year 2019-20 onwards, if the evaluation is not obtained from the relevant institutes after obtaining the evaluation and ranking, such institutes will be removed from this scheme until the evaluation and ranking is obtained and the scheme will be applicable to the students who take admission in the educational institutes which receive the ranking from that year onwards, will remain

### Procedure for Disbursement of Fee

Reimbursement:- (01) Eligible beneficiaries enrolling in the following vocational courses in the educational institutes under the scheme shall be taught through computerized online system. (02) It is necessary to submit the income certificate of the family (together with both the parents) for the students of Freed Caste and Nomadic Tribes, Other Backward Classes and Special Backward Classes attested by the competent authority and the income certificate should be from the concerned Tehvasaldar.

(03) Mentioning the specific computerized number of each beneficiary student's Aadhaar number. It is necessary to submit a certificate through the computerized system that the concerned student has appeared for the examination of the first semester / year of each year and submit the online certificate to the competent authority. (04) It shall be necessary to verify through the computerized system that each beneficiary student

is admitted and studying in the concerned educational system and is not registered as a non-student in the educational system.

(05) After receiving the online application, the Competent Authority shall verify the admission of the student in the course and whether the course transferred to the course has been approved by the course governing authority. Three Eligible students who are making repayments will also be considered eligible for the benefit of the scheme.

(07) For the courses for which the sessional examination system is not applicable, after the concerned student's presh is established by the concerned university and the registration number registered with the university, the eligible students taking admission in the concerned course and verifying the six pass marks for the benefit of the certificate, will be developed.
