REPORT OF ANTI-RAGGING COMMITTEE & SQUAD MEMBERS



6. Dr Sankalp Makrande was warned that if in future his name is involved in any such ragging incidences then he will be punished according to rules and regulations of anti ragging committee.



After conducting enquiry it was found that Dr. Anurag keskar has not indulged in any mental torture of any intern posted in department of Medicine.


