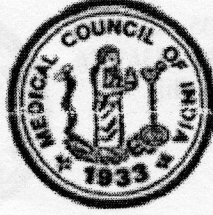

Sub: Uploading the Complete list of admitted students and the Status regarding the permission of courses on the college website.

Madam/Sir,

I am to invite your kind attention to this office letter no. No. MCI-34(MC)/2016-17/170031, dated: 15/02/2017, the matter with regard to "Vacant seats in the various Medical Colleges after the last date of admission was placed before the Monitoring Sub-Committee at its meeting held on 20/01/2017 and subsequently in Executive Committee meeting dated 25/01/2017. In order to bring more transparency and accountability in the admission process, it was decided that 'the Medical College Authorities should place the complete list of admitted students on the college website. This list should stay on the website, till the time all the students have passed final MBBS and obtained registration with State medical council.'" The changes to the list if any, in view of decision by regulatory bodies may be incorporated whenever direction to do so is received and updated list should be made available. A link, labelled as 'ADMISSIONS' should be placed in the Menubar of the 'Home Page' directing the visitor to the page with a table detailing the following.

As per the Schedule I Clause B.1.11, Minimum Standard Requirements for 50,100,150 MBBS Admissions annually Regulations, 1999, MCI-34(41)/2008-Med./29543, Gazette Notification published on 23/10/2008 the Medical Colleges are supposed to put all the information pertaining to permission/recognition for various courses on the college website and update it on a regular basis. Information in the form of documentary evidence regarding permission/recognition to a Medical College by the Central Govt. be uploaded on the website in the following format. A link, labelled as 'GOVT. APPROVAL' should be placed in the Menubar of the 'Home Page' directing the visitor to the page with a table detailing the following.
